## **INSTRUCTION FOR ONLINE BID SUBMISSION**

- 1. The tender form/bidder documents may be downloaded from the website: (<u>https://www.nbsslup.in</u>). Online submission of Bids through GeM (<u>https://gem.gov.in</u>) is mandatory. **Manual/Offline bids shall not be accepted under any circumstances.**
- Tender/bidders are requested to visit the Office website (<u>https://www.nbsslup.in</u>) and GeM (<u>https://gem.gov.in</u>) regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through these websites only.
- 3. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened on the next working day at the same time. The Bureau/Institute reserves the right to accept or reject any or all the tenders.
- 4. The Quantity proposed in the quotation may be increased or decreased at the discretion of Authority placing the order.
- 5. Quotation not found according to specification will be rejected.
- 6. Technical Evaluation:- before financial evaluation the bids shall be screened for eligibility in technical category on following basis: supporting documents in support of checklist. If any of discrepancy found at this screening stage the bids shall summarily be rejected.
- 7. Quotation should remain valid for 3 months from the date of their quotation.
- 8. The rate should be on F.O.R. on Kolkata basis. Prices are for comprehensive AMC.
- 9. The valid Firm registration certificate, Trade License, PAN, GST, Income Tax return certificate of last two financial years, Experience certificate/Work completion certificate/work order, ESIC, EPF registration certificate, Profession Tax registration certificate in W.B. should be submitted along with quotation.
- 10. The rates quoted should be clearly indicated the rates of items are inclusive of GST per annum.
- 11. The firm with its HQ in the same city/location of ICAR-NBSS & LUP, Regional Centre, Kolkata for which it is bidding shall be given preference.
- 12. Evaluation of financial bid: In case of more than one L1 bidder, the award will be given by the '*System Selection method*'.
- 13. Payment will be released in two installments of the total AMC value after satisfactory service rendered by the firm. An agreement for AMC on judicial stamp paper may be entered.

- 14. TDS as per rules shall be deducted from the bills of the contractor.
- 15. In case of any damage or loss to the ICAR-NBSS & LUP, Kolkata property or material directly or indirectly by the contractor's personnel, the contractor shall be held fully responsible, and the decision of the Competent Authority of ICAR-NBSS & LUP shall be final and binding on the contractor.
