Dear Candidate,

This has reference to the subject cited above. In this regard, this is to inform that while providing scores as per information provided in the proforma regarding employment of Dependents of Govt. servant while in service/retired on invalid pension as per the criteria of evaluation circulated vide F No 3-99/18-Admn/2127/30 dated 15.10.2024, the following discrepancy/deficiency were observed:

1) The information furnished by the applicant under Sr. No V of Part A of proforma i.e. "Particulars of all dependent family members of the Government Servant (if some are employed, their income and whether they are living together or separately)", in numerous cases details of family income has been not mentioned making it difficult to assign points to the individual applicant against point No 3 of evaluation sheet.

Therefore, the Annual Family Income is required to be furnished invariably and in case, income is less than Rs. 1,95,000/- per annum, Family Income Certificate from concerned Revenue Officers of the applicant is required to be attached. This is also to inform that in case, income mentioned is less than Rs. 1,95,000/- without Family Income Certificate, no points would be awarded against point No. 3 of evaluation Sheet.

2) The information furnished by the applicant under Sr No III (h) any other Assets, in numerous cases information is not provided or complete details are not furnished thereby making it difficult to assign points to the individual applicant against point No 4 of evaluation sheet.

Therefore, details along with location of all the property (Owned/Ancestral/other) along with its present approximate Market Value is required to be furnished invariably through an affidavit. In case, property is leased/Rented, lease agreement/rent agreement is required to be attached. This is also to inform that in case, above information is not provided, no points would be awarded against point No. 4 of Evaluation Sheet.

This is further to inform that above information may be submitted on or before 15th December 2024 failing which no points will be awarded against point No 3 & 4 of Evaluation sheet.

विषय - अनुकंपा नियुक्ति के संबंध में

यह उपरोक्त विषय के संदर्भ में लेख है कि F No. 3-99/18-Admn/2127/30 दिनांक 15.10.2024 द्वारा सूचित मूल्यांकन के मानदंडों के अनुसार सेवा में रहते हुये / सेवानिवृत्त होने पर अशक्त पेंशन पर आश्रित सरकारी कर्मचारी के रोजगार के संबंध में प्रोफॉर्मा में दी गयी जानकारी के अनुसार अंक प्रदान करते समय, निम्नलिखित विसंगति / कमी देखी गयी है :

1. आवेदक द्वारा प्रोफॉर्मा के भाग A के क्रमांक V के अंतर्गत दी गयी सूचना अर्थात " सरकारी कर्मचारी के सभी आश्रित परिवार के सदस्यों का विवरण (यदि कुछ कार्यरत है, तो उनकी आय और क्या वे एक साथ रहे रहे है या अलग अलग) ", कई मामलो में परिवार की आय का विवरण नहीं दिया गया है, जिससे मूल्यांकन पत्रक के बिन्दु संख्या तीन के लिए व्यक्तिगत आवेदन को अंक प्रदान करना कठिन हो गया है ।

इसलिए , वार्षिक पारिवारिक आय अनिवार्य रूप से प्रस्तुत की जानी चाहिए और यदि आय 1 लाख 95 हजार रूपये प्रति वर्ष से कम है तो आवेदक को संबन्धित राजस्व अधिकारियों से पारिवारिक आय प्रमाण पत्र संगलन करना होगा । यह भी सूचित किया जाता है कि यदि उल्लेखित आय 1 लाख 95 हजार रूपये से कम है तो , पारिवारिक आय प्रमाण पत्र के बिना, मूल्यांकन पत्रक के बिन्दु संख्या 3 के विरुद्ध कोई अंक नहीं दिया जाएगा ।


2. आवेदक द्वारा क्रमांक III (H) किसी अन्य संपत्ति के अंतर्गत दी गयी सूचना में, कई मामलो में सूचना प्रदान नहीं की गयी है या पूर्ण विवरण प्रस्तुत नहीं किया गया है, जिससे मूल्यांकन पत्रक की बिन्दु संख्या 4 के अंतर्गत आवेदक को अंक प्रदान करना कठिन हो गया है।

इसलिए, सभी संपत्तियों (स्वामित्व/ पैतृक /अन्य) के स्थान के साथ साथ उनके वर्तमान अनुमानित बाज़ार मूल्य का विवरण एक हलफनामे के माध्यम से प्रस्तुत किया जाना आवश्यक है। यदि संपत्ति पट्टे पर / किराये पर है तो पट्टा समझौता/ किराया समझौता संगलन करना आवश्यक है । यह भी सूचित किया जाता है की यदि उपरोक्त जानकारी प्रदान नहीं की जाती है, तो मूल्यांकन पत्रक की बिन्दु संख्या 4 के विरुद्ध कोई अंक नहीं दिये जाएंगे ।

यह भी सूचित किया जाता है की उपरोक्त जानकारी 31 दिसम्बर 2024 को या उससे पहले प्रस्तुत की जा सकती है अन्यथा मूल्यांकन पत्रक की बिन्दु संख्या 3 और 4 के लिए कोई अंक नहीं दिये जाएंगे ।
