Applications are invited for 01 position of **Technical Manpower (YP-I)**, purely on contractual basis, time bound and non-regular nature under the project entitled "Pilot Project on Crop Diversification" sponsored by Ministry of Agriculture and Farmers Welfare, Government of India. The closing date of application submission is **08th May, 2024**. The interview dates will be intimated *via* e-mail for the short-listed candidates to appear in the interview. The venue of the interview will be the ICAR-NBSS&LUP, Regional Centre, Delhi, IARI Campus, New Delhi-110012. Eligible candidates are requested to send their application in the enclosed proforma (Annexure-I) along with the declaration form (Annexure-II) and scanned copy of the original documents through email to Ashok.Kumar42@icar.gov.in with a copy to hd_rcd.nbsslup@icar.gov.in on or before **08th May, 2024** (closing date).

Original documents will be verified at the time of interview. Therefore, shortlisted candidates will be required to carry their recent biodata in the enclosed format along with original copies of the relevant documents. If any candidate found to have submitted false claims during screening or at later stage, their candidature will be summarily rejected.

Terms & Conditions

1. Above position is purely temporary and will be filled on contractual basis, and is only for two years from the date mentioned in the appointment order. The posts will be offered initially for a period mentioned above, and may be further extendable if the circumstances warranted to do so but based on periodic review and satisfactory performance for the extendable period during the project.

2. The services of YP-I is for the field work at local places in Mandi districts of Himachal Pradesh. Thus, preference will be given to local candidates. However, their services can be utilized at the CC-PIs Hqrs. (ICAR-NBSS&LUP, Regional Centre, Delhi) if need arises to do so to carry out the project related activities only. In such cases, the YP-I will not be entitled for any TA&DA from the project fund.
3. Selected YP-I will be engaged in activities pertaining to surveys mainly socio-economic survey, collection and compilation of field data/information for the assigned districts, collection of primary and secondary data of the study area for report preparation, and report writing.
4. If the candidate intends to apply for more than one location, he/she should clearly mention the location name in the application form. They need not submit multiple applications. Initially, candidates will be placed in the respective district of study area. After completion of field work he/she has to report to Dr. Ashok Kumar, CCPI at ICAR-NBSS&LUP, Regional Centre, Delhi regularly or as per need.
5. Candidates are instructed to submit their application as per the attached proforma (annexure-I) on or before the deadline (08th May, 2024), preferably through email to Ashok.Kumar42@icar.gov.in with a copy to hd_rcd.nbsslup@icar.gov.in.

Shortlisted candidates will be intimated with respect to any information regarding this through email only, and would bring their complete biodata/curriculum vitae with one photograph and duly self-attested certificates and mark sheets (From Class 10th onwards) along with original certificates in support of qualification, age, experience certificate and no objection certificate from their current employer, if any at the time of interview.
